When is a Permission required for a VTA?

If you are undertaking pest control operations that require the use of certain vertebrate toxic agents (VTAs), you may need a Permission from the Department of Conservation (DOC) and/or the Public Health Unit (PHU) of the local District Health Board. This requirement is set under Section 95A of the Hazardous Substances and New Organisms (HSNO) Act.

This information sheet provides details on the specific situations where a Permission is required. Guidance is also provided on how to obtain the Permission.

Permission from Department of Conservation

A Permission is required from the Department of Conservation for **ANY** VTA operation that is undertaken on land administered or managed by the Department of Conservation. To obtain this Permission, you will need to contact your local Department of Conservation Conservancy or Area office. A list of the contact numbers for the Conservancies is provided below. Note that you will need to fill out an application form or an Assessment of Environmental Effects (AEE) to obtain this permission, available from DOC. The application will require you to provide information on a range of matters relating to the VTA operation, including the location of the treatment (operational) area, proposed control methods and outcomes of any consultation.

Permission from the Public Health Unit (PHU) of the local District Health Board

A Permission is required from the PHU whenever any of the following VTAs are used or applied in a catchment area from which water is drawn for human consumption, or in any area where there is a risk to public health, for example in places where the public has access as of right (eg parks):

- 1080
- sodium cyanide or potassium cyanide
- yellow phosphorus
- 3-chloro-p-toluidine hydrochloride.

To obtain this Permission, you will need to contact the relevant PHU in the region the operation is to be carried out. A list of the contact numbers for the regional PHU Offices is provided below. You should not independently determine whether there may be a risk to public health and therefore whether or not a Permission is needed from PHU. In all cases, you should contact the relevant PHU. They are the agency with expertise in public health matters, and it is they who should advise you on whether a Permission is or is not required.

If you are advised that a Permission is required, you will need to fill out an application form to obtain this permission, available from the Health Protection Officer. The application will require you to provide information on a range of matters relating to the VTA operation, including the location of the treatment area, proposed control methods and outcomes of any consultation. A risk assessment is also required to be provided.
